BASIC GUIDELINES FOR AUTHORS

- Authors are requested to use the APA 7 (American Psychological Association) manuscript format and citation style https://apastyle.apa.org/style-grammar-guidelines/paper-format.
- The journal uses a double-blind review process; please remove all references to or clues about your identity as author(s) from the main text and footnotes.
- Manuscripts must be written in English.
- Submissions should be accompanied by an Abstract of up to 250 words to be sent to the Journal's email: deliberatio@e-uvt.ro.
- Submit 5 or 6 keywords.
- Accepted submissions should provide an author biography of up to 80 words.
- Authors are responsible for securing permissions and paying the required fees for the use of any material previously published elsewhere. Copies of permission letters should be sent to the Timisoara University Press (EUV) via the journal's dedicated email <u>deliberatio@e-uvt.ro</u> with the author's publication contract.
- Authors guarantee that the contribution does not infringe any copyright, violate any other property rights, or contain any scandalous, libelous, or unlawful matter.
- Authors guarantee that the contribution has not been published elsewhere and is not currently under consideration elsewhere.
- Authors are requested to submit their manuscript via: <u>deliberatio@e-uvt.ro</u>. DELIBERATIO is an Open Access journal. Published papers are currently not subjected to an Open Access fee. They will be published freely available for download through www.deliberatio.uvt.ro at no charge to the authors.

Manuscript Format ·

- Articles should be submitted as Microsoft Word files.
- All text, including notes and works cited should be formatted in Times New Roman font, size 12 point, with double line spacing throughout.
- Length: up to 7000 words for Extended Peer-Reviewed Article and Invited Feature Article, 3500 worlds for a Regular Peer-Reviewed Article and Review Article, 1500 words for Discussion and Book Review, and 500 words for Letter to the Editor.

Tables and figures: in compliance with https://apastyle.apa.org/style-grammar-guidelines/tables-figures.

Footnotes

As APA 7th recommends a limited use of (due to copyright permissions delays) you should use footnotes only when you consider it absolutely necessary, i.e. to add to or clarify a point or to add bibliographic and copyright information.

Content notes

Content notes provide supplemental information to your readers. When providing content notes, be brief and focus on only one subject. Try to limit your comments to one small paragraph.

Copyright permission notes

If you quote more than 500 words of published material or think you may be in violation of "Fair Use" copyright laws, you must get the formal permission of the author(s). All other sources simply appear in the reference list.

Copyright of your article

Authors submitting a manuscript do so on the understanding that they have read and agreed to the terms of the <u>Deliberatio Author Copyright Agreement</u>.
